Course Policies:

General Policy

Course Attendance Policy

Attendance is expected for all class periods. Attendance is required for presentation periods. Any absence must be accompanied by a written excuse from a doctor or other competent authority.

Missed Work

Without a valid excuse, a grade of zero points will be assigned for the missed work. If a valid excuse is provided:

- Make-up examinations and/or paper extensions will be given only if they are turned in before returned to students. In the event that a make-up examination or paper cannot be turned in before exams are returned to other students, the missed examination or paper will not count in calculating the course grade. This means that other graded work will be responsible for a greater weight in determining the course final grade.
- The final examination must be taken. Students missing the final examination should contact their instructor concerning the applicability of an [Incomplete grade](#).

Disruption of the Learning Environment
